3. The proposed project activity is listed at S. No. 3(b) under Category "B" (All Stand Alone Grinding Unit. Accordingly, the project proponent approached SEIAA, Maharashtra. SEIAA Maharashtra vide their letter dated 23/04/2021 opined that construction of Jetty and Cement plant are interdependent activities and both the units cannot be treated as independent projects Jetty and cement plant is an integrated activity, and which cannot be appraised in isolation and environment clearance Hence, project proponent should apply to MoEF&CC, New Delhi as an integrated project for Jetty and Cement Plant. Therefore, the project will be treated as Category "A" project and appraised at Central Level.

- 4. The instant Proposal was initially by the EAC in its 58th meeting held during 14-15th May 2024 wherein after detailed deliberations, the committee recommended the proposal for grant of Environment Clearance under the provisions of EIA Notification, 2006 subject to the stipulation of specific conditions and general conditions. The minutes of the meeting and all the project documents are available on PARIVESH portal which can be accessed at https://parivesh.nic.in.
- 5. The details of the proposal are as per the EIA/EMP report submitted by the proponent. The salient features of the proposal as presented during the above-mentioned meetings of EAC (Industry 1 Sector) are at **Annexure-II**.
- 6. The Unit configuration and capacity of the proposed project is at Annexure-III.

Deliberations of MoEFCC

- 7. The EAC, in its 58nd meeting held during 14 15th May, 2024, inter-alia, deliberated the following:
- i. The instant proposal is for establishment of a green field Cement Grinding Unit with Cement Production Capacity of 4.5 Million Metric Tons per Annum (MMTPA) and 0.5 Million Metric Tons per Annum (MMTPA) Fly ash/ Slag Processing Unit.
- ii. The EAC, constituted under the provision of the EIA Notification, 2006 comprising Expert Members/domain experts in various fields, examined the proposal submitted by the Project Proponent in desired format along with EIA/EMP reports prepared and submitted by the Consultant accredited by the QCI/ NABET on behalf of the Project Proponent.
- iii. The EAC noted that the Project Proponent has given an undertaking that the data and information given in the application and enclosures are true to the best of his knowledge and belief and no information has been suppressed in the EIA/EMP reports. If any part of data/information submitted is found to be false/ misleading at any stage, the project will be rejected and Environmental Clearance given, if any, will be revoked at the risk and cost of the project proponent.
- iv. The Committee noted that the EIA reports are in compliance of the ToR issued for the project, reflecting the present environmental status and the projected scenario for all the environmental components. The Committee deliberated on the proposed mitigation measure towards Air, Water, Noise and Soil pollutions. The Committee suggested that the storage of toxic/explosive raw materials/products shall be undertaken with utmost precautions and following the safety norms and best practices.
- v. The EAC noted that as per MoEF&CC O.M. dated 24/12/2010 pertaining to consideration of integrated and inter-linked projects, the project proponent is supposed to prepare a common EIA report after obtaining ToR from the concerned sectoral EAC. During EC process, the common EIA report will be appraised by the concerned sectoral EAC and make their recommendations relating to their particular component. Accordingly, the project proponent has obtained ToR from Infra sector of MoEF&CC vide letter no. 10-77/2018 IA III dated 09/10/2019 and Environment Clearance for the project of Berthing Jetty, Conveyor Corridor with Backup Storage Facilities and Approach Road to Cement Grinding Unit & Fly ash/Slag Processing Unit of Adani Cementation Limited vide letter no. 10-77/2018-IA.III/EC identification no. EC23A3501MH5535147N dated 29th December, 2023 on the basis of EIA/EMP Report prepared considering proposal of Cement Grinding Unit integrated with the Berthing Jetty project in compliance to the Ministry's OM dated 24th Dec., 2010. PP has also obtained the ToR for cement grinding unit from Industry 1 sector of MoEF&CC vide letter dated 25.08.2021 and now, has applied for EC by submitting the same EIA/EMP Report in compliance to the Ministry's OM

dated 24th December, 2010.

- vi. The EAC took into consideration the recommendations of the Infrastructure Sector pertaining to the interlinked project of Berthing Jetty, Conveyor Corridor with Backup Storage Facilities and Approach Road to Cement Grinding Unit & Fly ash/Slag Processing Unit of Adani Cementation Limited.
- vii. The EAC also took into consideration the drone survey of the project site and kml file on the Google Earth presented by the project proponent along with DSS of the project site on PARIVESH and made following deliberations accordingly.
- viii. The total project land is 10 ha, out of which 3.24 ha area is under the possession of ACL and rest 6.76 ha will be acquired soon. MoU/Consent from land owners regarding the remaining land has already taken. The present land use of the area is private agriculture land which will be converted into industrial upon introduction of the project.
- ix. PP has reported that there are around 113 villages falling within within the study area of the project site along with other sensitive areas. Proponent shall take appropriate environmental safeguard measures to minimise the impact on the habitation of the locals. The project proponent needs to strengthen green belt all around the plant area to reduce the dust pollution. The PP shall also include some of these locations in its environmental monitoring programme.
- x. The EAC noted that Amba River is at a distance of 0.4 km in East along with other water bodies within the study area of the project site. No construction activity/infringement shall take place in flood plain of Amba river situated in the vicinity of the project site. A robust and full proof Drainage Conservation scheme to protect the natural drainage and its flow parameters; along with Soil conservation scheme and multiple Erosion control measures shall be implemented.
- xi. PP reported that Mangrove Forest is at a distance of ~0.05 km form project boundary. The EAC deliberated on the Mangrove Conservation Plan submitted by the project proponent and is of the opinion that the plan shall be strictly implemented. There shall be regular monitoring and continual improvement in the conservation plan.
- xii. The water requirement for the proposed project is estimated as 800 m3/day, which will be obtained from the Maharashtra Industrial Development Corporation (MIDC). The EAC deliberated on the water requirement is of the opinion that PP shall obtain necessary permission from the Competent Authority in this regard.
- xiii. The Committee has deliberated on the baseline data along and incremental GLC due to the proposed project and is of the opinion that mitigation measures shall be strictly implemented.
- xiv. There are total thirteen Schedule I species which are Jackal (Canis aureus), Indian Porcupine (Hystrix indica), Common Mongoose (Herpestes edwardsii), Indian chameleon (Chamaeleo zeylenicus), Indian Rat Snake (Ptyas mucosa), Cobra (Naja naja), Sparrow hawk (Accipiter nisus), Marsh harrier (Circus aeruginosus), Pale harrier (Circus macrourus), Pied harrier (Circus mclanolcucous), Peregrine falcon (Falco Peregrinus), Osprey (Pandion haliaetus) & River tern (Sterna aurantia) in the study area of 10 km radius. Company has prepared Wildlife Conservation Plan and allocated Rs. 990 lacs for the same. Wildlife Conservation Plan for approval was submitted to DCF, Thane on 3rd Nov., 2022. Currently the Revised Wildlife Conservation Plan including the Schedule I species as per the Wild Life (Protection) Amendment Act, 2022 dated 19th December, 2022 and the same has been forwarded from APCCF-WL, Mumbai to PCCF, Nagpur for final approval. The EAC opined that Wildlife Conservation Plan shall be strictly implement post approval.
- xv. The PP has submitted that greenbelt will be developed in 3.3 ha which is about 33 % of the total project area. A 50 m toward Mangroves side, 15 m toward Jetty and 5 m wide greenbelt consisting of at least 3 tiers around plant boundary will be developed as greenbelt and green cover as per CPCB/MoEF&CC, New Delhi guidelines. Total no. of 8250 saplings will be planted and nurtured in 3.3 hectares in three years. The EAC deliberated on the greenbelt layout plan along with action plan and the budget earmarked and is of the opinion that greenbelt shall be completed within a period of 1 year.
- xvi. The Committee also deliberated on the public hearing issues along with action plan submitted by the proponent to address the issues raised during the public hearing and found it satisfactory.
- xvii. The committee deliberated details of carbon foot prints and carbon sequestration study w.r.t. proposed project and found them to be satisfactory.

xviii. The EAC also deliberated on the written submission of the project proponent and found it satisfactory.

xix. The EAC deliberated on the proposal with due diligence in the process as notified under the provisions of the EIA Notification, 2006, as amended from time to time and accordingly made the recommendations to the proposal. The Experts Members of the EAC found the proposal in order and recommended for grant of environmental clearance.

xx. The environmental clearance recommended to the project/activity is strictly under the provisions of the EIA Notification 2006 and its subsequent amendments. It does not tantamount/construe to approvals/consent/permissions etc. required to be obtained or standards/conditions to be followed under any other Acts/ Rules/ Subordinate legislations, etc., as may be applicable to the project. The project proponent shall obtain necessary permission as mandated under the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981, as applicable from time to time, from the State Pollution Control Board, prior to construction & operation of the project.

xxi. The EAC also reviewed the EC conditions (specific and general) pertaining to Industry-I projects and observed that some of the specific conditions stipulated so far in the previously recommended EC projects are common and applicable to most of the projects in general. In view of the same, the General Conditions (in case of EC projects) have been revised through reallocation of these common conditions from specific to General Conditions (in case of EC projects). Accordingly, the instant project is also being stipulated with the modified General conditions.

8. The EAC (Industry-1 Sector), in its 58th meeting held during 14 – 15th May, 2024, based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for grant of Environment Clearance subject to stipulation of specific and general EC conditions(Annexure I).

Decision of MoEFCC

- 9. The MoEF&CC has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee (Industry-1 Sector) hereby decided to grant Environment Clearance for instant proposal of M/s. Adami Cementation Limited under the provisions of EIA Notification, 2006 subject to the following specific conditions and general conditions (Annexure-I)
- 10. The Ministry reserves the right to stipulate additional conditions, if found necessary at subsequent stages and the project proponent shall implement all the said conditions in a time bound manner. The Ministry may revoke or suspend the environmental clearance, if implementation of any of the above conditions is not found satisfactory.
- 11. Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of the Environment (Protection) Act, 1986.
- 12. Any appeal against this environmental clearance shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
- 13. The above conditions shall be enforced, inter-alia under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981, the Environment (Protection) Act, 1986, Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 and the Public Liability Insurance Act, 1991 along with their amendments and Rules and any other orders passed by the Hon'ble Supreme Court of India / High Courts and any other Court of Law relating to the subject matter.
- 14. This issues with approval of the competent authority.
