Further to our letter dated October 9, 2024, we wish to inform you that the QIP committee of the board of directors ("QIP Committee") at its meeting held on October 15, 2024, has *inter alia*, passed the following resolutions:

- a. Approving the closure of the Issue today, i.e. October 15, 2024;
- b. Determining and approving the Issue price of ₹2,962.00/- per Equity Share (including a premium of ₹2,961.00/- per Equity Share), which takes into account a discount of 4.99% (i.e. ₹155.4750/- per Equity Share) to the floor price of ₹3,117.4750/- per Equity Share determined as per the formula prescribed under Regulation 176(1) of Chapter VI of the SEBI ICDR Regulations, for the Equity Shares to be allotted to the eligible qualified institutional buyers in the Issue;
- c. Approving and adopting the placement document; and
- d. Approving and finalising the confirmation of allocation note to be sent to the eligible qualified institutional buyers, intimating them of allocation of Equity Shares pursuant to the Issue.
- e. Approving issuance of refund intimation letter to the bidders who are entitled to receive any refund amount, if any.

The meeting of the QIP Committee commenced at 10:30 p.m. concluded at 11:00 p.m.
