Chargé d'Affaires of US Embassy, said at the launch of a book titled 'All About Municipal Bond' in New Delhi Thursday. VMC's case study is a part of the book.

"The book is a compilation of the process of issuing the bond. It

is a case study that has been before March 31, 2022. Therefore, jointly put together by VMC, under the guidance of our former Commissioner, Shalini Agarwal, and the US Treasury, which was our adviser in the process, VMC's bond has been chosen as a case study as it has been the most successful municipal bond in the country with the highest subscription and a low yield price." said VMC's Chief Accountant Santosh Tiwari

VMC listed a five-year Rs 100 crore bond at the Bombay Stock Exchange (BSE) on March 23. The municipal bond will be used for 14 projects under AMRUT scheme and received 36 bids on the BSE BOND platform for Rs 1,007 crore—10 times the issue size.

VMC had received the subscription amount of Rs 100 crore at a yield of 7.15 per cent—the lowest ever coupon rate in the category of municipal bond after SEBI regulations. "By far, this stands as the most competitive and lowest rate amongst municipal bond issuances in India. Further, it also made the VMCeligible for an incentive of Rs 13 crore from the Central government as it has been successful in raising money through bonds

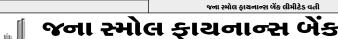
